- Janet **Asherson** is CBI's Head of Environmental Affairs with responsibility for developing CBI's policy on health and safety.
- *Tony Baldry* is a Conservative MP with a keen interest in health and safety. A former minister, he is also a director of a number of public companies in the UK and abroad.
- *David* **Bergman** is the Executive director of the Centre for Corporate Accountability. He has written widely on workplace safety and corporate accountability issues.
- *Nick Brown* M.P. is the Minister for Work and is the minister responsible for health and safety as well as industrial injury benefits.
- *Vincent Cable* M.P. is the shadow Trade and Industry Secretary for the Liberal Democrats with responsibility for the safety portfolio.
- *Ross* **Cranston** Q.C. is a Labour M.P. for a West Midlands constituency who recently tabled a Ten Minute Rule bill on Directors Duties. He is a former Solicitor General.
- Andrew **Dismore** is a Labour M.P. who has tabled an amendment to the Criminal Justice Bill that would have created an offence of Corporate Killing.
- *Lord* **Falconer** is the Home Office Minister for Criminal Policy with responsibility for reform to the law of manslaughter.
- *John Halford* is a solicitor at Bindmans specialising in public law. He worked for many years at the Public Law Project and has worked closely with the CCA on its advice work.
- Anne **Jones** is the mother of Simon Jones who was killed at Shoreham Docks in April 1998 on his first day at work. Euromin Ltd and its managing director were charged with manslaughter but aquitted.
- *Tony Lloyd* M.P. is chair of the Trade Union Group of Labour MPs and was shadow spokesperson on Health and Safety in the early 1990s.
- *Moira* **Martin** is the wife of David Martin who was crushed to death in December 2002 in a factory in Newcastle. The HSE failed to prosecute a director of the company.
- Andrew Morgan is a solicitor at the solicitors Field Fisher Waterhouse and specialises in occupational disease cases.
- *Patricia Peter* is a Corporate Governance Executive at the Institute of Directors.
- *Lawrie* **Quinn** is Labour M.P. for Scarborough and Whitby and is piloting the Health and Safety (Offences) Bill through the Commons.
- *George* **Stewart** is the father of 24 year old Paul who died in the Avonmouth Gantry Collapse in September 1999. The Coroner had refused to hold an inquest into the death.
- *Neal Stone* is the Head of the Innovative Engagement Unit at the HSE which is responsible for developing the organisation's policy on 'Directors' Duties'
- *Steve* **Tombs** is Professor of Sociology at John Moores University in Liverpool. He is co-author of the book "Corporate Crime" published in 1999 by Longmans. He is the Chair of the Board of the Centre for Corporate Accountability.
- *Owen Tudor* is a Senior Policy Officer at the TUC, a member of the Industrial Injuries Advisory Council and a member of the Health and Safety Commission.
